## ABSENTEE BIDDER CONTRACT

This Absentee Bidder Contract on the accompanying Absentee Bid Form is a legal and binding contract to bid on one or more items at the Handline's Auctions event in which personal property will be auctioned off by Ohio state Dept. of Agriculture auctioneer John Handline, Sr. By signing this contract I will be held to my purchase(s) if awarded the winning bid (high bid) on any one or more items for which I have placed an absentee bid for. Absentee bids must be received no later than the beginning of the auction by a representative of Handline's Auctions, Handline's Auctions and/or John Handline, Sr. and all absentee bids must be accompanied by a credit card number at the time you sign your absentee bidder form. If you are the winning bidder we will charge the winning bid and buyer's premium at the end of the auction. We will either then make arrangements to pickup at Auction location or take the item to our warehouse and if needed process for shipping or pickup. If item/s needs to be shipped a 2<sup>nd</sup> charge for the Shipping and Handling of the item/s will be charged to the Credit Card given.

I hereby give permission to Ohio State Dept. of Agriculture licensed auctioneer, John Handline, Sr that is selling property for Handline's Auctions at the event, to bid on my behalf. Under the auspices of this contract I understand the following:

- Handline's Auctions or a representative of Handline's Auctions will represent me and bid competitively on my behalf on the following items up to the maximum bid noted on this form;
- The bidders attending the auction will take precedence over my absentee bid in the event of a tie;
- If a winning bid at live auction is a tie resulting from two or more absentee bids, the earliest bid to arrive will be awarded the winning bid; If there is a tie with an Absentee Bid and a Live Floor Bidder the tie will go to the Live Floor Bidder
- The purchase price for any winning bid will be the total of my winning bid(s) plus a 15% buyer's premium and will be charged to my credit card at the completion of the auction; and Sales Tax if being collected for the auction.
- My bid will not be executed by the state licensed auctioneer and/or staff member of Handline's Auctions without this signed "Absentee Bid Form" in his possession the day of the auction;
- I am responsible for reviewing the item(s) I am bidding on and know that all items at auction are sold as-is, where-is, with no expressed or implied warranty and that all sales are final;
- Absentee bids are a convenience and I will not hold Handline's Auctions, and/or Handline's Auctions Staff and any of its representatives responsible for errors or any failures to execute my bid(s).
- There is a Start and Max Bid Section. If you just place a Max Bid only then starting bid will be **\$10.00 minimum** or the floor bid if higher. If you provide a higher than our minimum Starting Bid then that is what the Bid will start at and we then continue up to your Max bid.
